- a. Those who wish to source beef or pork from Berry Hill Farm Organics LLC must own a portion of the company. Berry Hill Farm Organics LLC leases a commercially equipped butcher facility located at the farm headquarters but this facility is not inspected by any government entity and the red meat products processed in this facility cannot legally be sold.
- b. Beef and pork processed in this way can only be distributed to co-owners. The price being charged is not a sale of the meat but rather the production cost associated with the portion being received by the co-owner. As a co-owner of Berry Hill Farm Organics LLC, you own a portion of the whole enterprise but are only expected to pay the overhead expenses of the product you receive for your own use. Money received by Berry Hill Farm Organics LLC, from the co-owners is entirely designated to cover expenses of running the company and does not in any way constitute a sale transaction between Berry Hill Farm Organics LLC and the co-owner.
- c. Berry Hill Farm Organics LLC, exists for the purpose of owning livestock to supply a safe, pasture based, beyond organic, supply of meat for its owners. The overhead costs and purchase of animals, feed, & etc. is to be apportioned as nearly as possible to the individual product being supplied to the co-owners.
- d. This business is not expected to generate a profit or any tax liability for its owners. We must have a tax ID on file for each owner and there will be an annual document generated for tax purposes but no profit or loss is anticipated that will have any impact on the co-owner's personal tax liability. We reserve the right to charge a \$50 annual processing fee to each owner in the event they take less than \$500 per year of product.
- e. As a co-owner you are personally responsible to inspect Berry Hill Farm Organics LLC, livestock production and processing facilities to ensure it meets your personal standard for cleanliness, humaneness, and any other criteria that is important to you. The operational partners have high personal standards and will do their best to fill the standards of other co-owners in the methods of operating the farm and processing the meat products. Each co-owner is ultimately responsible to ensure that his or her personal standard is being met. Drop in spot checks are allowed at any time but to ensure personal safety please contact the facility manager, Harold Schrock @ 315 723 1681 whenever you plan to visit the Berry Hill Farm Organics LLC facility, located at 2388 Green Vedder Rd. Deansboro NY, 13328. The real estate owners are not liable for any injuries sustained by Berry Hill Farm Organics LLC co-owners in the event that they are not being escorted by the facility manager. Keep in mind that a working farm and/or abattoir can be a hazardous environment.
- f. Schrock family members own a controlling interest in Berry Hill Farm Organics LLC and will make the day-to-day management decisions. Any concerns or requests from other co-owners will be taken into full consideration.
- g. If Berry Hill Farm Organics LLC fails to meet any of your expectations, or if for any reason ownership is no longer in your best interest, Berry Hill Farm Organics LLC will purchase back your portion of a share at the price you paid when originally joining Berry Hill Farm Organics LLC.
- h. As a co-owner of a New York registered LLC, your personal liability from the actions of the LLC is limited to the amount you have invested. If the LLC is dissolved for any reason with outstanding liabilities you may not receive back the purchase price of your portion.
